**Glenn B. Miller** is Principal and Founder of MBG Finance. His career has proven both diverse and entrepreneurial, spanning roles from banking executive through to corporate finance, in addition to restructuring, asset-based lending and patron of the arts. In 2002, Glenn founded Emergia Capital, an asset-based lending firm specializing in corporate renewal and distressed debt, which he rebranded as MBG Finance in 2009.

MBG Finance is an established privately owned fund structured as a financial lending and advisory firm that specializes in asset-based lending, investment banking, advisory services, and corporate governance. As of July of 2020, Glenn has partnered up with STS Capital (Agility) as Managing Director, a new division within STS, that specializes in restructuring advisory services and corporate renewal.


## **Current Advisory Board Roles:**
